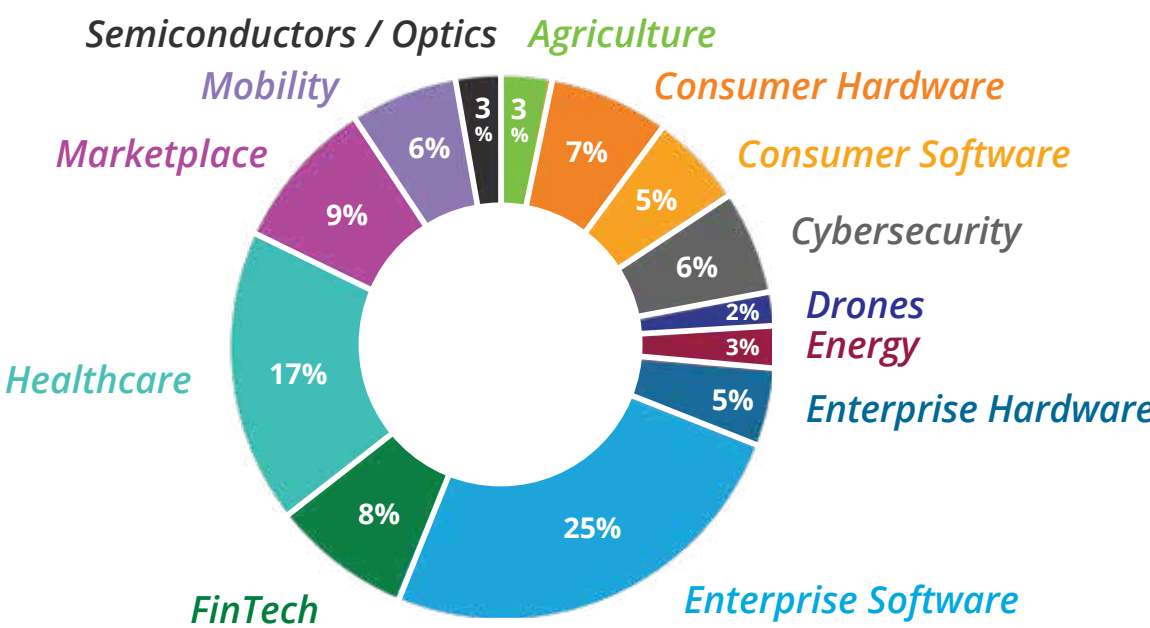
This past year, OurCrowd expanded operations and partnerships throughout **Asia**:

Investments

In 2017, OurCrowd expanded into new investment areas and launched new funds.

2017 investment highlights:



12 Funds, including:

- Qure** – First closing in mid-2017
- Cognitiv** – \$100M AI Fund
- Oxx** – Partnership with Europe-based growth stage fund

Agriculture: The oldest field of human innovation, now operating with smart sensors, optics, and drone tech with companies like **Taranis**.

Healthcare: AI is creating Smart Medicine across healthcare, including **Dreamed**, artificial pancreas for diabetes management; **Scopio**, improving diagnostics with next-gen microscope; and **BrainQ**, AI algorithms for neuro rehab.

Industrial safety: Drone AR platform **Edgybees** helped rescue missions after deadly hurricanes hit the southern US. **Airobotics** helps to protect large industrial sites using their advanced autonomous drone system.

Maniv Mobility, Israel's first mobility fund, raises \$42M.

Zoomcar launched its bike sharing platform in India.
